Welcome

1. Mr. Benitez welcomes everyone and roll call is taken.

II. Public Comments:

1. There are no public comments.

III. Minutes:

 Mr. Benitez moved to review the minutes from previous LSLC meeting on March 18, 2021. Ms. Ostorga moved to approve the minutes. Mr. Benitez seconds. Ms. Marron concurs.

IV. School Re-Opening Plan Overview:

- 1. Mr. Benitez reviewed our Reopening Plan point by point.
- 2. Mr. Benitez clarified that After School Care will be available to all students but that it is really recommended for parents who truly need supervision due to work or other commitments.
- 3. Mr. Benitez explained the Morning Entrance and Dismissal procedures. There will be well defined and clearly marked areas for both Parents and Students as well as clear directional markings throughout the campus for safe movement. Yellow tape will clearly indicate where students can sit (socially distanced).
- 4. Mr. Benitez stated that each student will be provided their own assorted Recess Play Equipment (YoYo's, hula hoop, etc.).
- 5. Mr. Benitez stated that the area behind the cafeteria may be used as "outdoor" classrooms if necessary (under tents).

V. Discussion/Comments:

- 1. Ms. Hernandez thanks Mr. Benitez for sharing the Reopening Plan and mentions that she would be able to donate tape.
- 2. Ms. Marron asks if Orchestra Class will remain on Zoom. Mr. Benitez states that "yes" the class will remain on Zoom.
- 3. Ms. Marron asks about play equipment/sanitizing. Mr. Benitez states that each student will have their own equipment (no sharing).
- 4. Ms. Marron asks if students can bring a snack to school. Mr. Benitez states that students can bring their own snacks to be eaten outdoors. In addition, students will be taking meals home (grab n go).
- 5. Ms. Marron asks about the disinfecting of classrooms. Mr. Benitez states that all classrooms will be disinfected 2x per day.

- 6. Ms. Hernandez expressed concern that many parents have questions about the vaccine. Ms. Schramling reiterated that Parents should always check our Social Media sites as she posts updates regularly.
- 7. Ms. Ostorga asks about the plan for Parents as they wait outside to enter. Mr. Benitez states that we will be using 3 entrances which should alleviate the crowd size and allow for more social distancing. He also states that he is considering allowing siblings to enter and wait safely on the yard.
- 8. Ms. Ostorga asks if students should bring chargers to school. Mr. Benitez states that this is something that is yet to be determined.
- 9. Ms. Marron asks if teachers can make copies for students. Mr. Benitez states that copies can be made and recommends placing copies on each students desk the day before.
- 10. Ms. Fleishman asks if Teachers are to stay with their students for dismissal. Mr. Benitez states that Teachers will be dismissing their own students and will wait with students for 10 minutes.
- 11. Ms. Hernandez suggests that we try to have some fun activities for the students (dance contest, calligraphy class, etc) because they have been on Zoom for so long. Mr. Benitez states that he welcomes these great ideas.
- 12. Mr. Benitez states that he is making videos for the students to help them learn about all of our new procedures for coming back to school.

1. Mr. Benitez moved to adjourn the meeting at 4:09pm. Ms. Marron seconded the motion. Ms. Becerra concurred.
